We are a part of the NETPWFA, North East Texas PeeWee Football Association. The towns involved in the league are: Community, Princeton, Farmersville, Caddo Mills and Royse City.

The registration fee's will go towards the purchase of your uniforms, trophies and will help maintain the fields, purchase Insurance and additional improvements as we pursue forward into the future.

Cheer costs will vary from year-to-year based upon the uniforms. Cheer uniforms will be maintained for two consecutive years before any changes in the logo, color, type, and print are made. Therefore, the rate for cheer in the first year will be a full cost, for those in their second year it will be substantially less.

Authorization and Release of All Claims

In consideration of the acceptance of my application for my child in the Caddo Mills Youth Sports Association ("CMYSA") to participate in the Football and Cheer program, and for my child to be fully permitted to engage in the activities of CMYSA, I, for myself and my child, hereby waive, release, and discharge any and all claims for damages for fatal injury, personal injury or property damage, whether or not resulting from the negligence, gross negligence or misconduct of any person, that I may have, or that may subsequently accrue to me, as a result of my child's participation in the activities of CMYSA. This release is intended to discharge in advance the board of directors, organizers, sponsors, supervisors, other participants, persons transporting my child to and from activities, officials, and any municipalities or other public entities (including their respective agents and employees), from and against any and all liability arising out of or connected in any way with my child's participation in CMYSA activities, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above.

I further understand that serious accidents occasionally occur during football, cheerleading, and drill team activities and that participants in such activities occasionally sustain serious personal injuries as a consequence thereof. Knowing the risks of these activities, nevertheless, I hereby agree on my own behalf and that of my child to assume those risks and to release and to hold harmless all of the persons or entities mentioned above who (through negligence or carelessness) might otherwise be liable to me or my child (or to our heirs or assigns) for damages.

It is further understood and agreed that this waiver, release, and assumption of risk is to be binding on my heirs, and assigns as well as those of my child.

I understand and agree that the liability insurance carried by CMYSA is only secondary insurance to my own personal insurance coverage, which I acknowledge is current and will remain current during the playing season.

I give my child's head coach and his assistant the right to seek medical treatment in case of injury if I cannot be located. I also release all official and professional personnel from any claim whatsoever on account of first aid, treatment or service rendered to my child during participation in a CMYSA activity.

I have identified all medical problems that CMYSA should be aware of and have provided all special instructions in the Medical Emergency Information section.

I agree to return, upon request, the equipment issued to my child promptly and in good condition, except for normal wear, and I may be billed up to \$200 for equipment and/or uniforms that are not returned.

I will furnish a birth certificate for my child named on the application form to CMYSA upon request, and understand that it must be provided before the first game.

I understand that photographic, video, and/or other images of my child may be obtained and used in the media, on the CMYSA website, or in other CMYSA promotional and publicity materials at the discretion of the CMYSA Football and Cheer Board of Directors, and that if I do not wish my child's image to be used for these purposes, I must request so in writing.

I have received and agree to carefully read the information provided by CMYSA.

I expressly agree that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Texas and that, if any portion of the

agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I state that I have carefully read the above release and know the contents of the release and sign this release as my own free act.

This release contains the entire agreement between the parties to this agreement and the terms of this release are contractual and not a mere recital.
