CHILD ABUSE STATEMENT

Clovis Rockets Organization have a great deal of concern about the safety and abuse of children. As a person who is interested in the well being of children, we believe you are entitled to know how our organization is combating this critical issue. In addition, as an applicant for a staff position with our organization, you need to know the defensive measures we employ to protect children in our care, as well as the staff form this serious problem.

We will not tolerate the abuse of any child. We make an active and, we believe, effective to prevent child sexual abuse in our program. We attempt to screen out molesters through a careful background check. We structure our activities recommending that staff not to be left alone with children. We periodically interview children about their experiences in our program, and encourage open discussion of their problems. We take any allegation by children and others very seriously, and refer all allegations to the local or State law enforcement authorities for investigations in which we fully cooperate.

The Clovis Rockets Softball Organization is a risky place for molesters to attempt to abuse children. In addition, the safeguards built into our activities protect staff from being in situations that might be misinterpreted by children and others.

CONSENT FOR CRIMINAL BACKGROUND HISTORY CHECK AUTHORIZATION/WAIVER/INDEMNITY

I hereby give my permission for the Clovis Rockets Softball Organization to obtain information relating to my criminal history record. The criminal history record, as received from the reporting agencies, may include arrest and conviction data as well as plea bargains and deferred adjudication's. I understand that this information will be used, in part, to determine my eligibility for any position with this organization. I also understand that as long as I remain in a position with the organization, the criminal history records check may be repeated at any time. I understand that I will have an opportunity to review the criminal history a procedure is available for clarification, if I dispute the record as received.
