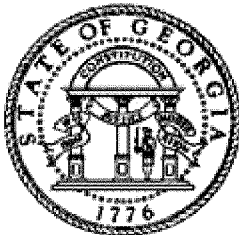

ARTICLES OF INCORPORATION
OF
Kennesaw Girls Softball Association, Inc.

The undersigned incorporator to these Articles of Incorporation, being at least eighteen years of age, hereby forms a corporation for non-profit under the Georgia Nonprofit Corporation Code #14-3-202 as follows:

ARTICLE I

Name and Address

The name of this Corporation Kennesaw Girls Softball Association, Inc. Its primary mailing address will be 7030 Sumit Creek Dr., Kennesaw, Georgia 30152.

ARTICLE II

The Corporation is organized pursuant to the Georgia Nonprofit Corporation Code.

ARTICLE III

Initial Registered Office and Agent

ARTICLE VI

- 2) A related purpose shall be to conduct all administrative, financial, and other functions of the Association as are required and in doing so provide worthwhile recreational activity for those involved in the programs (Competitive Slow Pitch Program, Fast Pitch Program and Recreational Program) of the Association.
- 3) This club is organized and shall operate as a not-for-profit organization for social welfare, civic improvement and other similar non-profit purposes. Any income received shall be applied only to the non-profit purposes and objectives of the organization and no part of the income shall insure to the benefit of any officer or member.


ARTICLE VII
