CONSENT, AUTHORIZATION, WAIVER & INDEMNITY FOR BACKGROUND CHECK

I hereby give permission to Northwest Austin Youth Basketball Association, Inc. (NWAYBA) to obtain information related to my criminal history record. The criminal history record, as received from reporting agencies, may include arrest and conviction data, as well as information related to plea bargains, deferred adjudications, and delinquent conduct committed as a juvenile. I understand this information will be used in part to determine my eligibility for a volunteer coaching position in NWAYBA. I also understand my criminal history record can be checked by NWAYBA any time and on more than one occasion. I understand that I will be granted the opportunity to review the criminal history record received by NWAYBA if I request it. And, a procedure is available for clarification if I dispute the criminal history record NWAYBA receives. I also understand the criminal history could contain information presumed to be expunged.

I, the undersigned, do, for myself, my heirs, executors and administrators, hereby remise, release, and forever discharge and agree to indemnify NWAYBA and the agency that provides the criminal history record (as well as their officers, agents, affiliates, co-sponsors, representatives, coaches, volunteers, subcontractors or employees) and hold them harmless from and against any and all causes of actions; suits; liabilities; costs; debts; and sums of money, claims, and demands whatsoever (including claims for negligence, gross negligence, and/or strict liability) and any and all related attorney's fees, court costs, and other expenses resulting from the investigation of my background in connection with my application to become a volunteer coach.
