T-Ball: Pre-School & Kindergarten (Batting "T" used all season. Games @ 6pm or 7pm on Tues & Thur) **Cost: \$50.00**

(To be eligible, must turn 4 by 4/30/12 no exceptions. Registration Maximum is 16 teams.)

Northern League: Grades 1st & 2nd (Games @ 5:30pm or 7pm on Wed&Thurs, Lincoln Field) **Cost: \$75.00**

(Kindergarteners MAY be allowed to play in Northern League if they have participated for at least ONE YEAR in the RBI T-ball program AND space permitting AFTER ALL eligible 1st and 2nd graders are placed. Registration Maximum is 16 teams.)

Minor League: Grades 3rd & 4th (Evaluation required. Games mostly @ 6:15pm on Mon/Wed) **Cost: \$100.00**

(2ND Graders MAY be allowed to play in Minors if they have previously participated in the RBI Northern league program AND evaluate in the TOP 50% of all Minor League Players AND space permitting AFTER ALL eligible 3rd and 4th graders are placed as of the Evaluation Date. Placement order is determined by player evaluation. 2nd graders MUST participate in evaluations to be considered for the space available spots in Minors. Registration Maximum is 16 teams.)

Major League: Grades 5th, 6th & 7th (Eval. required. Games mostly @ 6:15pm on Tues/Thurs) **Cost: \$125.00**

(To be eligible, can not turn 13 before 5/01/12. 4th Graders WILL be allowed to play in Majors if they have previously participated in the RBI Minor League Program AND evaluate in the TOP 50% of all Major League Player AND space permitting AFTER ALL eligible 5th, 6th and 7th graders are placed as of the Evaluation Date. Placement order is determined by player evaluations. 4th graders MUST participate in evaluations to be considered for a spot in Major League Division. Registration Maximum is 16 teams)
