- 1.) Voluntarily and of my own free will, I elect to participate as a member of the softball team and league indicated on the front page.
- 2.) I understand that there are certain risks and hazards involved in participating in softball including, but not limited to those hazards associated with weather conditions, playing conditions, equipment and other participants in addition to the acts of pitching, throwing, fielding and catching of the ball, the swinging of bat, running, jumping, stretching, sliding, diving and collisions with other players and with stationary objects, all of which can cause serious injury or death to me and other players. Further, I agree that I consider for the for the right to play as a member of the team designated on the reverse side and in consideration for permission to play on the field arranged for by the team or league:

I voluntarily elect or accept and solely assume all risk of damages injury, including death, incurred or suffered by me (A) while practicing or playing as a member of the team so designated, (B) while serving in a non-playing capacity as a team member or observer during practice of play by other teams or by other players on my team, and (C) while on or upon the premise of any and all of the fields arranged for by my Team or league for practice or play.
- 4.) I release, discharge and agree not to sue the team and/or league designated below or any owner or lease of fields on which softball is played or practiced by my team or Team Unity and City of Lathrop/Mossdale Community Park for any claim, damages, costs or cause of action which I have or may in the future have as a result of injuries or damages sustained or incurred by me from whatever cause including but not limited to the negligence, breach of contract or wrongful conduct of the parties hereby released. I further agree that I should hold harmless and fully indemnify the parties hereby released from any claims, damages, costs, including attorney fees, and cause of action which may arise from any claim or cause of action made by me, through me or on my behalf even if the damages, injuries or death are caused in whole or in part by any of the parties or entities hereby released.
