



VACAVILLE JUNIOR BULLDOGS (VJB) -- WEBMASTER OR WEB-CONTROLLER AGREEMENT

VJB website is intended for the informational and entertainment use of the public with special consideration of children under 18 years of age. The understanding of the terms of uses below need to be understood, agreed upon and signed.

Vacaville Jr. Bulldogs Youth Football and Cheerleading plans to post videos and/or pictures of its past, present and future participants on its website as a representation of the Vacaville Jr. Bulldogs organization (VJB). This means that your friend, family member, you or your child's picture, name and jersey number may be placed on the site or television show. The intent is to promote the organization and website in a positive and community driven manner and to give acknowledgment of the participation or success of individuals or groups within the organization and the league. The league or its members will not release or use any pictures for any other use besides team cohesiveness events or items (ie, yearbooks, plaques, team shirts) without parental authorization. VJB does not guarantee or control intents of outside entities.

4. Prohibited Uses:

- (I) **DISTRIBUTION OR SHARING** OF USERNAMES OR PASSWORDS TO UNAUTHORIZED USERS.
- (II) **UPLOAD TO OR CREATE ON THE SITE** ANY PRODUCED CONTENT THAT VIOLATES ANY LAW, REGULATION, TREATY OR THIRD PARTY RIGHT (INCLUDING, WITHOUT LIMITATION, PRIVACY, OR PUBLICITY RIGHTS); PUBLISHING OF FALSEHOODS OR MISREPRESENTATIONS THAT COULD DAMAGE VJB OR ANY THIRD PARTY;
- (III) **POST, UPLOAD TO, OR CREATE ANY PRODUCED CONTENT** THAT IS UNLAWFUL, OBSCENE, DEFAMATORY, LIBELOUS, THREATENING, PORNOGRAPHIC, VULGAR, HARASSING, HATEFUL, RACIALLY OR ETHNICALLY OFFENSIVE, OR ENCOURAGES CONDUCT THAT WOULD BE CONSIDERED A CRIMINAL OFFENSE, GIVE RISE TO CIVIL LIABILITY, VIOLATE ANY LAW, OR, IN VJB' SOLE DISCRETION, IS OTHERWISE INAPPROPRIATE; POST ADVERTISEMENTS OR SOLICITATIONS OF YOUR OR ANY OTHER BUSINESS OR BUSINESSES WITHOUT APPROVAL OF THE VJB BOARD OR VJB WEBMASTER THAT HAS NOT BEEN APPROVED OR HAS PROVIDED SPONSORSHIP TO THE VJB LEAGUE.
- (IV) **EMBEDDED MATERIAL**, ALLOWING ACCESS TO UNCENSORED MATERIAL (I.E. youtube.com OR myspace.com)
- (V) INTENTIONALLY INTERFERE WITH OR DAMAGE OPERATION OF THE VJB WEBSITE OR ANY USER'S ENJOYMENT OF THEM, BY ANY MEANS, INCLUDING UPLOADING OR OTHERWISE DISSEMINATING VIRUSES, ADWARE, SPYWARE, WORMS, OR OTHER MALICIOUS CODE.
- (VI) **POLITICAL REFERENCES** – NO POLITICAL SPONSORS OR IDEALIST SHALL BE PLACED OR REFERRED TO ON THE VJB WEBSITE OR ITS SUB-SITES.
- (VII) **IMPERSONATE ANOTHER PERSON OR ENTITY**, WHETHER ACTUAL OR FICTITIOUS, FALSELY CLAIM AN AFFILIATION WITH ANY PERSON OR ENTITY, OR ACCESS THE VJB WEBSITE ACCOUNTS OF OTHERS WITHOUT PERMISSION, MISREPRESENT THE SOURCE, IDENTIT, OR CONTENT OF INFORMATION TRANSMITTED VIA THE VJB VJB WEBSITE, OR PERFORM ANY OTHER SIMILAR FRAUDULENT ACTIVITY; MAKE UNSOLICITED OFFERS, ADVERTISEMENTS, PROPOSALS, OR SEND JUNK MAIL OR SPAM TO OTHER USERS OF THE VJB WEBSITE. THIS INCLUDES, BUT IS NOT LIMITED TO, UNSOLICITED ADVERTISING, PROMOTIONAL MATERIALS, OR OTHER SOLICITATION MATERIAL, BULK MAILING OF COMMERCIAL ADVERTISING, CHAIN MAIL, INFORMATIONAL ANNOUNCEMENTS, CHARITY REQUESTS, AND PETITIONS FOR SIGNATURES.
- (VIII) **USE THE VJB WEBSITE FOR ANY ILLEGAL PURPOSE**, OR IN VIOLATION OF ANY LOCAL, STATE, NATIONAL, OR INTERNATIONAL LAW, INCLUDING, WITHOUT LIMITATION, LAWS GOVERNING INTELLECTUAL PROPERTY AND OTHER PROPRIETARY RIGHTS, AND DATA PROTECTION AND PRIVACY; DEFAME, HARASS, ABUSE, THREATEN OR DEFRAUD USERS OF THE VJB WEBSITE, OR COLLECT, OR ATTEMPT TO COLLECT, PERSONAL INFORMATION ABOUT USERS OR THIRD PARTIES WITHOUT THEIR CONSENT, OR, EXCEPT AS EXPRESSLY AUTHORIZED HEREIN, USE MATERIALS, THIRD PARTY PRODUCED CONTENT, OR OTHER CONTENT ON THE VJB WEBSITE FOR ANY COMMERCIAL USE.
- (IX) You agree that VJB, in its sole discretion, for any or no reason, and without penalty, may suspend or terminate any account (or any part thereof) you may have with VJB or your use of the VJB WEBSITE and remove and discard all or any part of your account, User profile, and any produced content, at any time. VJB may also in its sole discretion and at any time discontinue providing access to the VJB WEBSITE, or any part thereof (including without limitation all Materials), with or without notice. You agree that any termination or suspension of your access to the VJB WEBSITE or any account you may have or portion thereof may be effected without prior notice, and you agree that VJB will not be liable to you or any third party for any such termination.
- (X) Any suspected fraudulent, abusive or illegal activity may be referred to the local or state law enforcement authorities.
