In addition to the League Bylaws, Standing Rules, and League Code of Conduct, I will fulfill and abide by the following:

- ⇒ Participate in the background check process at my own expense
- ⇒ Attend the "Meet My Coach" Day
- ⇒ Designate no more than two assistant coaches and a team manager
- ⇒ Practice at the approved locations (Edgewood Middle School, West Covina High School, I Cameron Community Center)
- ⇒ Attend all coaches meetings as needed
- ⇒ Abide by all rules and regulations set forth by the WCYBL
- ⇒ Treat all players equally and instruct them in the fundamentals of youth basketball
- ⇒ Abide by disciplinary decisions made by the Board of Directors
- ⇒ Make sure all members of my team clean our bench
- ⇒ Make sure my team, parents, and spectators respect the rules and regulations regarding cleaning, maintenance, safety, and refreshments in the gymnasium
- ⇒ Allow referees or officials to have the final decision during games
- ⇒ Make sure only the head coach, asst. coach, and/or team have contact with players during games and practices
- ⇒ Attend league meetings, functions, and events, and assist in any way possible
- ⇒ My identification card will be visible at all league functions, practices, and games
- ⇒ Do not promote gambling or wagering against or for any player or team
- ⇒ Do not meet with any player (male or female) alone at any time
- ⇒ Do not allow unauthorized individuals to "fill-in" at any time
- ⇒ Do not Leave the bench for any reason, unless instructed to do so by a game official or league representative
